Empower local communities so they can solve their environmental problems on their own.






### The tools we use to assist communities:

- **Small grants** (over 2 400 projects CZK 220 million in grants)
- Fellowships and study tours
- Technical assistance and services to local communities
- Own programs focused on:
  - improving public spaces
  - planting trees
  - greenways and improving infrustructure for nonmotorized transport
  - traffic calming and safe routs to schools
  - environmental education
  - energy saving and climate protection



#### **Regional context – 5,900 projects**

protect over 160 endangered species of flora and fauna plant more than 225,000 trees insulate 800 homes, schools, and other public buildings create over 4500 km of cycling paths and nature trails employ 2,350 people (full-time, part-time, definite period of time) mobilize and involve over 21,500 volunteers

# Greenways: linking people, places, and ideas

- multifunctional trails for non-motorized users typically leading along linear green corridors, historic trade routes, rivers and railways
- managed by local people in order to encourage sustainable development and healthy lifestyle









# Mobilizing communities through planting trees

- alleys and tree lines as traditional component of the Czech countryside
- orchards of old fruit varieties as cornerstone for small scale business projects of local communities
- parks and green spaces as essentials for healthy urban spaces





# Improving public spaces with the community involvement

- lively, functional and healthy public spaces
- designed and managed by the local community local government, entrepreneurs, NGO's and citizens

# Major challenges of the sector and communities:

- increasing inherence of the governments, while not securing consistent policies
- **lack of independent sources** such as endowed foundations
- low tax and legal motivation for private donors to support NGO activities
- over-complicated and not well targeted EU
   programs inacessible for small stakeholders
- Big **demand for small grants** in user-friendly procedures (5-10 times higher than available funding)
- Economic depression might cause decline of NGO capacity to deal with growing social problems



# SWISS CONTRIBUTION - NGO Block Grant

### **Basic facts:**

- Total amount: 5,000,000 CHF
- Area of intervention: the Moravian-Silesian Region, the Olomouc Region, (the Zlín Region)
- Duration: 5 years (3 open calls for applications)

- Associations
- Public benefit companies
- Caritas and Deaconess
- Foundations and foundation funds



### **Grant scheme implementation**

### **NGO projects to be supported:**

- Two major fields of activity:
  - social services
  - and environment (with possibility of institutional grants)
- Size of grants:

Range recommended by the tender: 10,000 – 250,000 CHF, most probable upper limit: 1,5 million CZK

• Co-financing: 10 %
