**Subject Message to Gambling websites of your responsibility**

Dear regulator representative,

1. According to the Greek legislation, (law no 4002/2011-A 180 and regulatory decisions 51/3/26.04.2013, 200/11.04.2016, 250/2/16.03.2017) and 319/3/27.04.2018, Hellenic Gaming Commission performs audits, in order to detect websites which provide unauthorized gambling services in the Greek Territory (Greek IP).
2. As a result, the Hellenic Gaming Commission adds the aforementioned websites (plus the legal or physical persons owed each website) to the Catalogue of non-Licensed Gambling Operators via internet (Blacklist). The Hellenic Gaming Commission publishes the Catalogue of non-Licensed Gambling Operators via internet (Blacklist), including the non-licensed websites/domain names and the companies/legal/physical persons who are responsible for the operation of those websites/domain names.
3. Immediately after the publication of the Blacklist, **ISPs have to block the access from the Greek Territory (Greek IP)** to all blacklisted websites/domain names.
4. Furthermore, immediately after the publication of the Blacklist, banks/credit institutions have **to block every transaction** between the player and the companies/legal/physical persons owed the blacklisted websites/domain names.

According to the above, we would very much appreciated if you were kind enough to inform all the companies which are licensed by your Authority that there is a simple way to prevent the risk of being blacklisted, by displaying the following message (in Greek and English language) at the home page of their gambling sites:
